

1. TO INSURE SAFETY

Obey the driver at all times

Follow the driver's instructions promptly

Keep the aisles and step well clear at all times

Stand at a safe distance from the curb and roadway

Always cross in front of the bus when crossing the street

Students will be loaded and unloaded at their designated stop only

2. ITEMS THAT ARE NOT ALLOWED ON THE BUS

No food or drinks except water

No glass containers of any kind

No live animals or insects of any kind

Large objects must be in a case or duffle bag

Skateboards/in-line skates

Basketballs, footballs, soccer balls

Band/musical instruments

No gang related attire allowed

3. UNACCEPTABLE BEHAVIOR

- A) No abusive or obscene language or inappropriate gestures
- B) No physical violence or intimidation (bullying)
- C) No horse-play or yelling across the bus
- D) No standing or changing seats while the bus is in motion
- E) No sticking any body part or throwing an object out the window
- F) No smoking, drug paraphernalia, alcohol or weapons
- G) No littering
- H) No destruction of property (vandalism or graffiti)
- 1) No spraying perfume or cologne
- J) No kissing or fondling between couples

4. ROUTE SCHEDULE (Students residing within 1.5 miles from the school are not eligible for transportation.)

Students must be visible and at their stop 10 minutes prior to scheduled pickup time

Driver will not wait for tardy students

No unauthorized stops or rerouting will be made (unless weather and/or construction conditions warrant a change)

Students must show a student ID and/or pass to ride the bus
